<b>1. Content and intended learning outcomes</b>						
Content	The degree program will introduce students to the phenomenon of slavery and its various manifestations, as well as other forms of strong asymmetrical dependency. Students will learn about <ul style="list-style-type: none"> <li>- definitions of slavery and forms of dependency</li> <li>- essential scholarship on slavery and the emerging canon on other forms of strong asymmetrical dependency</li> <li>- relevant methods from textual studies and material and social sciences, and empirical approaches</li> <li>- classical and recent theory with reference to strong asymmetrical dependencies and slavery in textual studies, material sciences and across empirical disciplines, enabling them to interrogate theory texts</li> <li>- academic work and research techniques</li> </ul> Students will gain <ul style="list-style-type: none"> <li>- experience in the planning and design of research projects and</li> <li>- the ability to present and write about their findings by acquiring presentation and writing techniques in English</li> </ul>
